




Vision


A people oriented, environmentally sensitive, effective and guiding solution centre, working for the global city of Istanbul.

Istanbul Development Agency perceives development as a multidimensional holistic concept; including development of social rights alongside economic development, environmental conscience, and protection of cultural values; and acts with an understanding of development which mobilises the potential of all segments of society. The Agency embraces fundamental values and operational principles such as productivity, innovation, sustainability, being scientific, sensitivity to the environment and to cultural values, and participation in its activities and projects. Drawn up to serve for Turkey's Goals for the Year 2023 and Istanbul's 2023 Vision, the Istanbul Regional Plan is a high-scale scheme that sets out Istanbul's socio-economic development trends, potential for growth, domains of priority for response and industrial goals, and drives the strategic plans to be drawn up by public organizations including local authorities in particular.

The Regional Plan sets out Istanbul's industries of priority as financial services, information and communication technologies, healthcare, creative industries, logistics, tourism and construction. Through joint efforts with our partners, we strive to boost the competitive edge of the aforementioned industries.

Types of Grants

Providing a great deal of project grants, Istanbul Development Agency aspires to help Istanbul achieve the goals in the vision for the 2023 Regional Plan **by enhancing collaborations among a variety of stakeholders such as the public authorities, the private industry, universities and non-governmental organizations.**


I. GUIDED PROJECT GRANTS

A guided project is a project of particular nature that provides direct grants without calling for any project proposal, and the subject and requirements of which are designated under the guidance and leadership of the Agency in line with the priorities set out in the regional plan.

For areas of priority designated in the Istanbul Regional Plan or as a result of field studies, Istanbul Development Agency is entitled to provide any guided project with grants as long as their operating model, partnership structure, ownership status and project cost are all set. As a part of guided projects, the Agency promotes partnerships of universities, public authorities, the private industry and non-governmental organizations.

For guided projects that are usually intended to boost how the private industry works, it is essential to

- Build capacity for manufacturing and exports,
- Set good practices,
- Promote industrial diversity and specialization
- Develop, transfer or disseminate know-how, skills and technologies
- Develop a local financing pattern
- Promote partnerships between universities and businesses
- Improve new service and manufacturing organizations,
- Establish cooperation networks and a value chain
- Foster clusters
- Develop a new industrial type of infrastructure and organizational patterns
- Develop human resources in areas that regional industries would need



II. CALL FOR PROJECT PROPOSALS

This is a call on potential applicants, the qualifications of whom are clearly set, to propose projects in line with previously-designated themes and requirements as a part of a certain support program run by the Agency. Since its inception, ISTKA has issued calls for project proposals in a variety of themes such as Social Inclusion and Social Cohesion, Knowledge-Based Economic Development, Environmentally and Energy Friendly Istanbul, Barrier-Free Istanbul, Disaster Preparedness, Children and Youth, Innovative Istanbul, Fight Against Addiction, and Employment of Women.

III. DIRECT OPERATIONAL GRANTS

This is a grant provided by the Agency for any research, plan and feasibility study that would contribute to seize on major opportunities for the region's development and competitive edge, take urgent measures in eliminating threats and risks leveled at the region's economy, and kick off and take strategic actions that are potentially crucial for the region.


Your Business Partner in Istanbul: ISTKA Investment Support Office

Engaged in various cooperation and capacity building efforts with a view of attracting domestic and international investors to Istanbul, the ISTKA's Investment Support Office serves as a local department dealing with procedures concerning certificates of investment incentives in accordance with "the Decree No. 2012/3305 on the Resolution for Governmental Aids for Investments". To this end, the ISTKA's Investment Support Office is entrusted with tasks and powers to deal with applications as required by the legislation, report follow-ups on regional projects and carry out procedures for completion visas concerning certificates of investment incentives.
